ORDER TO CONTINUE HEARING

This cause came on for consideration before the Oklahoma State Board of Medical Licensure and Supervision on March 23, 1996 at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Mary Ann Gilliam, M.D., Defendant, appeared by way of legal counsel, Donald Davis of Oklahoma City, Oklahoma.

The Oklahoma Board of Medical Licensure and Supervision heard a joint motion to continue this hearing until May 9, 1996 and being fully advised in the premises, the Board of Medical Licensure and Supervision finds as follows:

FINDINGS OF FACT

- 1. That Defendant, Mary Ann Gilliam holds Oklahoma Medical License Number 9089, which is currently suspended temporarily until the matter can be heard by the Board, en banc.
- 2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as

required by law and the rules of the Board.

- 3. That Defendant's legal counsel sought continuance of the evidentiary hearing scheduled for March 23, 1996 and agreed that the defendant's medical license would remain suspended until the next meeting of the Oklahoma Board of Medical Licensure and Supervision presently scheduled for May 9, 1996 and the Defendant would thereby not practice medicine and surgery in the State of Oklahoma during that interim time period.
- 4. That based upon the representations of legal counsel as to temporary suspension and that Defendant would not practice medicine and surgery in the interim period, legal counsel for the Plaintiff agreed to continuance of the evidentiary hearing.
- 5. That the grounds for the continuance and the representations by Defendant's legal counsel were sufficient to obtain continuance of the evidentiary hearing herein.
- 6. That no danger to the public health, safety and welfare exists under the current status of suspended license.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

- 1. That hearing on the matter before the Board in this instance should and is hereby continued to May 9, 1996.
- 2. That until the meeting of the Board on May 9, 1996, the license of Mary Ann Gilliam, Number 9089 remains suspended and the Defendant shall not practice medicine and surgery in the State of Oklahoma until further order of this Board.
