FINAL ORDER REDUCING LEVEL OF PROBATION SUPERVISION

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision en banc on the 23rd day of January, 1988, at the office of the Oklahoma State Medical Association, 601 NW Expressway, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff, and John B. Freidenberger, M.D., Defendant, did not appear in person but appeared through his letter request of October 12, 1987.

The Board of Medical Licensure and Supervision en banc heard the testimony and reviewed exhibits and being fully advised in the premises, the Board of Medical Licensure and Supervision therefore finds as follows:

FINDINGS OF FACT

- That Defendant, John B. Freidenberger, M.D., holds 1. Oklahoma Medical License No. 9270.
- That the Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
- That Defendant has for a substantial time fulfilled all terms and conditions of probation previously imposed and the Defendant's request to reduce his level of supervision to Level II is not objected to by the Board staff and should be GRANTED.

CONCLUSIONS OF LAW

The Board has inherent power to modify or shorten the terms and the period of probation and the level of supervision of any Defendant under Board jurisdiction, 59 O.S. Supp. 1987, \$506 et seq.

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

That the level of probation on Defendant John B. Freidenberger, M.D., should be and the same is hereby reduced to

Level II probation and that supervision of the Defendant should remain at that level until further order of the Board. Λ
