**FINAL ORDER**

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision ("Board") on May 16, 1997, at the office of the Board, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Gerald Snider, M.D., Defendant was present in person along with Roger Eldredge, Attorney for Defendant.

The Board en banc heard testimony, reviewed exhibits and being fully advised in the premises finds as follows:

**FINDINGS OF FACT**

1. That Defendant, Gerald Snider, M.D., holds Oklahoma Medical License No. 9483.
2. That the Board has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.
3. That the Board accepted a Voluntary Submittal to Jurisdiction on

January 9, 1997 which included a suspension following by probation.

4. That Defendant has been unable to serve the community service as required by the Voluntary Submittal to Jurisdiction.

#### CONCLUSIONS OF LAW

1. That the Board has jurisdiction in its discretion and judgment over this matter pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, Title 59 O.S., Sec. 481 et seq and by the Voluntary Submittal to Jurisdiction executed by the Defendant.

#### ORDER


IT IS THEREFORE ORDERED to allow the suspension of Gerald Snider, M.D., Defendant, to expire on May 26, 1997 on the condition that all court costs assessed have been paid and to begin a five (5) year probation under terms and conditions, to-wit:

1. Defendant will serve ten (10) hours a week community service and reappear before the Board at the July 24, 25, 26, 1997 meeting and submit a report regarding the community service.
2. Defendant may not act as a consultant on any patient Defendant has treated during the past five (5) years.
3. Defendant shall provide the Board with any requested reports or files immediately upon request.
4. Defendant will keep the Board informed of his current address.
5. Defendant will keep current payment of all assessment by the Board for prosecution, investigation and monitoring of his case.
6. Until such time as all indebtedness to the Board has been satisfied, Defendant will reaffirm said indebtedness in any and all bankruptcy proceedings.
7. Defendant shall conduct his practice in compliance with the Oklahoma Allopathic Medical and Surgical Licensure and


Supervision Act.

8. Defendant shall furnish to each and every state in which he holds licensure or applies for licensure and hospitals, clinics or other institutions in which he holds or anticipates holding any form of staff privilege, a copy of the Board Order stipulating sanctions imposed by the Board.
9. Any violation of the terms of this Order shall constitute grounds for additional action by the Board herein.
10. The jurisdiction of the Board in this action shall continue until the terms and conditions of probation are ended, or modified, or lifted by the Board upon motion.
