ORDER DENYING TERMINATION OF PROBATION

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on March 26, 2009, at the Board's office, 5104 North Francis, Suite C, Oklahoma City, Oklahoma 73118, pursuant to notice given as required by law and rules of the Board.

Elizabeth A. Scott, Assistant Attorney General, represented the State of Oklahoma. Howard Edward Hagglund, M.D., appeared in person, *pro se*, thereby waiving his right to legal counsel at the hearing.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

Findings of Fact

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.
2. Dr. Hagglund currently holds medical license no. 9798 under an indefinite term of probation that commenced on January 17, 2008. Dr. Hagglund's Final Order of Probation provides that at the end of one (1) year, he was to appear before the Board so that it could review his practices and compliance with the probationary terms.

3. On March 26, 2009, Board staff on behalf of Dr. Hagglund requested that his probation be terminated.

4. The proposed termination of Dr. Hagglund's probation does not afford sufficient practice limitations or controls to assure that Dr. Hagglund can practice medicine with reasonable skill and safety.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to hear requests for termination of probations under 59 Okla. Stat. §480 *et seq.*

2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 Okla. Stat. §480 *et seq.*


ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Board staff's request for termination of Dr. Hagglund's probation is **DENIED**. Dr. Hagglund's probation shall be extended for an additional year after which time he shall appear before the Board so that it can review his practices and compliance with the probationary terms.

2. A copy of this written order shall be sent to Dr. Hagglund as soon as it is processed.


